

Tuition Rates

St. Louis Catholic High School strives to provide a well-rounded, faith-based education at a tuition level that is accessible to as many students as possible. Around 40% of St. Louis students pay less than the top rate through the support of church subsidies, scholarships, financial aid or sibling discounts.

2024-2025 TUITION RATES

The 2024-2025 Subsidy Form to obtain your Pastor's signature and secure the subsidized tuition rate is available in the information below.

SUBSIDIZED TUITION

- One Child (Subsidized) – \$7715
- Two Children (Subsidized) – \$15,044
- Three Children (Subsidized) – \$21,602
- Four or more Children (Subsidized) - \$26,231

NON-SUBSIDIZED TUITION

- One Child (Non-Subsidized)- \$8715
- Two Children (Non-Subsidized) - \$16,994
- Three Children (Non-Subsidized)- \$24,402
- Four or More Children (Non-Subsidized) - \$29,631

- Registration Fee – \$500 (Non-refundable)
- Administrative Fee – \$250
- Technology Fee – \$200
- Activity Fee – \$50
- Graduation Fee (Seniors only) – \$140

SUBSIDIZED TUITION

Tithing parishioners at one of the 15 Diocese of Lake Charles parishes that support St. Louis Catholic High School may be eligible for subsidized tuition.
